Valuation for Traditional Retail Insurance Replacement

Item 1

One, 14ct yellow gold and rhodium plated, gem set, multistone ring, of hand-assembled construction.

Plain, narrow, low half round, tapered band of 3.09mm width (at base) x 0.90mm depth, with a hollow top and shoulders, and open back settings.

Feature rectangle top plate, housing three rows of four round brilliant cut diamonds, claw set. The top plate is secured between the decorative pierced shoulders, of the plain and polished band. Rhodium plating to the diamond setting areas.

Polished finish.

Stamped 'unknown makers mark 14K 585 V09IJB Sive' - acid tested as 14 carat gold.

Ring size: V 1/2.

The ring contains:

Twelve claw set round brilliant cut diamonds, clarity is "Vs & Si" (mixed), colour is "H to I" (mixed).

Dimensions = 2.10mm(Dia) x 1.28mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 2.20mm(Dia) x 1.34mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.50ct (estimated - see NOTE below)

Total Item Weight = 4.00 grams

Total Gemstone Weight = 0.50ct

Total Metal Weight = 3.90 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
