Valuation for Traditional Retail Insurance Replacement

Item 1

One, 9ct white gold, gem set, 'cluster' style ring, of hand-assembled construction.

Plain, narrow, low half round band of 1.74mm width (at base) x 1.19mm depth, with a curved underrail.

Feature rectangle top plate, with three tapered baguette cut diamonds, to the centre, claw set. To the top and bottom is one row of three round brilliant cut diamonds, claw set. The floating surround and shoulders are embellished with a total of thirty round brilliant cut diamonds, varying slightly in size, and claw set. The top plate is secured to the underrail and in between the extended and square shoulders, of the plain and polished band.

Polished finish.

Stamped '9K 0.80ct' - acid tested as 9 carat gold.

Ring size: S.

The ring contains:

Three claw set tapered baguette cut diamonds, clarity is "Vs & Si" (mixed), colour is "I to J" (mixed).

Dimensions (average) = 3.60mm(L) x 1.80mm(W) x 1.31mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.21ct (estimated - see NOTE below)

Thirty Six claw set round brilliant cut diamonds, clarity is "Vs & Si & P1 & P2" (mixed), colour is "I to J" (mixed).

Dimensions = 1.50mm(Dia) x 0.92mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 1.85mm(Dia) x 1.13mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.59ct (estimated - see NOTE below)

Total Item Weight = 3.26 grams Total Gemstone Weight = 0.80ct Total Metal Weight = 3.10 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
