Valuation For Traditional Retail Insurance Replacement

Item 1

One lady's cast 9ct white gold, diamond set square cluster style ring.

Low half round, tapered from 2.15mm in width at base x 1.29mm in depth shank. Upper section of inner shank of pierced style. Shoulders of split style, claw and bead set with round brilliant cut diamonds. Feature square cluster setting with a raised centre, bead set with round brilliant cut diamonds. Bead set surround of round brilliant cut diamonds. Polished finish, stamped "JP21 375" and acid tested as 9ct. Finger size = J



The ring contains:

Three bead and claw set round brilliant cut diamonds, clarity "VS", colour "G to J", medium to good cut quality.

Dimensions = 2.30mm(Diameter) x 1.40mm(D-estimated) (smallest)

Dimensions = 2.75mm(Diameter) x 1.68mm(D-estimated) (largest)

Total Weight = 0.20ct (estimated) see NOTE below

Sixty Four bead and claw set round brilliant cut diamonds, clarity "VS, Si & P1", colour "G to L", medium to good cut quality.

Dimensions = 1.00mm(Diameter) x 0.61mm(D-estimated) (smallest)

Dimensions = 1.75mm(Diameter) x 1.07mm(D-estimated) (largest)

Total Weight = 0.80ct (estimated) see NOTE below

Total Item Weight = 3.40 grams, Total Gemstone Weight = 1.00ct, Total Metal Weight = 3.20 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the diamonds cannot be ascertained. Therefore, weights of the diamonds are very much estimated. For accurate testing, weights, colour, and clarity gradings, the diamonds require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
