Valuation for Traditional Retail Insurance Replacement

Item 1

One, hand-assembled, 14ct yellow gold and 14ct white gold, multistone, gem set ring.

Plain, wide, tapered band of 3.64mm in width (at base) x 1.33mm depth, with open back (cut-out) settings.

Feature 'cross-over' style ring design, having a white gold setting, housing five round brilliant cut diamonds, tapering in size, channel set. The shoulders of the yellow gold plain and polished band, with a grooved design.

Polished finish.

Stamped '14K FG Y & unknown symbol' - acid tested as 14 carat gold.

Finger size is P.

The ring contains:

Five channel set round brilliant cut diamonds, clarity 'Si & P1' (mixed), colour 'G'.

Dimensions = 2.10mm(Dia) x 1.28mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 2.67mm(Dia) x 1.63mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.22ct (estimated - see NOTE below)

Total Item Weight = 7.40 grams

Total Gemstone Weight = 0.22ct

Total Metal Weight = 7.36 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
