## Valuation for Traditional Retail Insurance Replacement

## Item 1

One, hand crafted, 18ct yellow gold, multistone, gem set ring.

Plain, narrow, tapered band of 4.60mm at top to 2.40mm in width (at base) x 0.74mm depth, with open back (cut-out) settings.

Feature 'bar' ring design, housing one round brilliant cut diamond to the centre, with six round brilliant cut diamonds, tapering in size, in groups of two each side, all bar set.

Polished finish - unstamped - acid tested as 18 carat gold. Finger size is N.



One bar set round brilliant cut diamond, clarity 'Vs', colour 'I'.

Dimensions = 4.48mm(Dia) x 2.73mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.35ct (estimated - see NOTE below)

Twelve bar set round brilliant cut diamonds, clarity 'Si & P1' (mixed), colour 'H to J' (mixed).

Dimensions = 1.95mm(Dia) x 1.19mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 2.23mm(Dia) x 1.36mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.40ct (estimated - see NOTE below)

Total Item Weight = 4.50 grams - Total Gemstone Weight = 0.75ct - Total Metal Weight = 4.35 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
