

Valuation for Traditional Retail Insurance Replacement

Item 1

One, lady's hand finished, raised 18ct white gold & diamond set. multistone ring. Plain, wide, low half round, tapered band, measures 6.68mm width (at base) x 0.85mm with curved underrail.

Feature, "wave ribbon" style ring design. Comprising, 10 x single claw set rows, alternating with five channel set, rows to top. Housing thirty four baguette cut diamonds, channel set. Containing one hundred & six round brilliant cut diamonds, claw set. The extended shoulders, of the band, tapers up wide & splits into the rows on top, from both sides.



Polished finish, stamped "198?" - acid tested & x-rayed as 18 carat gold. Finger size = O.

The ring contains;

Thirty Four channel set baguette diamonds, clarity is "Si", colour is "G", medium cut quality.

Dimensions = 2.46mm (L) x 1.25mm (W) x 0.91mm (D-estimated)

Total Weight = 0.92ct (estimated - see NOTE below).

One Hundred And Six claw set round brilliant cut diamonds, clarity is "Si, P1 & P2"(mixed), colour is "G to J"(mixed), medium cut quality.

Dimensions = 1.46mm (average diameter) x 0.89mm (D-estimated)

Total Weight = 1.06ct (estimated - see NOTE below).

Total Item Weight = 13.06 grams, Total Gemstone Weight = 1.98ct, Total Metal Weight = 12.66 grams, (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
