Valuation for Traditional Retail Insurance Replacement

Item 1

One, hand-assembled, 10ct rose gold, multistone, gem set ring, of cast construction.

Plain, wide, tapered band of 12.77mm at top to 3.46mm in width (at base) x 1.28mm depth, with hollow top and shoulders, curved decoratively pierced underrail, and open back settings.

Feature multi-row ring design housing seven round brilliant cut diamonds, largest then tapering in size, channel and shared bead set. The outer rows each channel set with eleven round brilliant cut diamonds, also tapering in size.



Polished finish - stamped '10K michael hill 3.00' - acid tested as approximately 10 carat gold. Finger size is Q.

The ring contains:

Twenty Nine shared bead & channel set (mixed) round brilliant cut diamonds, clarity 'P1 & P2' (mixed), colour 'H to I' (mixed).

Dimensions = 2.60mm(Dia) x 1.59mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 3.90mm(Dia) x 2.38mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 3.00ct (estimated - see NOTE below)

Total Item Weight = 8.51 grams

Total Gemstone Weight = 3.00ct

Total Metal Weight = 7.91 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
