Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct yellow gold and 18ct white gold, gem set, 'dress' style ring, of hand-assembled construction.

Plain, narrow, low half round, tapered band of 1.55mm width (at base) x 0.50mm depth.

Feature central white gold four claw setting, housing one emerald cut natural aquamarine, claw set. The 'leaf' shaped white gold shoulder plates, house two single cut diamonds, bead set, the edges are embellished with millegrain detail. The settings are secured to the plain and polished yellow gold band, the shoulders of which are dished to the centre.



Polished finish.

Stamped '18CT' - acid tested as 18 carat gold.

Ring size: Q.

The ring contains:

One claw set emerald cut natural aquamarine, colour is "blue"

Dimensions = 7.06mm(L) x 4.97mm(W) x 3.20mm(D-estimated)

Total Weight = 0.76ct (estimated - see NOTE below)

Four bead set single cut diamonds, clarity is "Vs & Si" (mixed), colour is "G to I" (mixed).

Dimensions (average) = 1.20mm (diameter)

Total Weight = 0.03ct (estimated - see NOTE below)

Total Item Weight = 3.20 grams Total Gemstone Weight = 0.79ct Total Metal Weight = 3.04 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
