Valuation for Traditional Retail Insurance Replacement

Item 1

One, lady's hand finished, raised 18ct white gold, diamond set, multistone ring. Plain, narrow, low half round band, measures, 2.18mm width (at base) x 1.33mm depth, with curved underrail, open back settings underneath. Feature, 'illusion claw setting' to top. The extended shoulders, of the band, tapers up wide, channel set both sides.

Polished finish, stamped "MHJ, 750" - acid tested as 18 carat gold. Finger size O.

The ring contains;

One illusion claw set Princess cut diamond, clarity is "Si", colour is "G", medium cut quality.

Dimensions = 3.45mm (L) x 3.45mm (W) x 2.45mm (D-estimated)

Total Weight = 0.25ct (estimated - see NOTE below).

Four illusion claw set baguette diamonds, clarity is "Si & P1" (mixed), colour is "G to H" (mixed), medium cut quality.

Dimensions = 3.36mm (L) x 1.58mm (W) x 1.15mm (D-estimated)

Total Weight = 0.20ct (estimated - see NOTE below).

Twelve channel set Princess cut diamonds, clarity is "Vs & Si" (mixed), colour is "G to H" (mixed), medium cut quality.

Average dimensions = 1.45mm (L) x 1.45mm (W) x 1.03mm (D-estimated) (smallest)

Average dimensions = 2.00mm (L) x 2.00mm (W) x 1.42mm (D-estimated) (largest)

Total Weight = 0.50ct (estimated - see NOTE below).

Total Item Weight = 3.93 grams, Total Gemstone Weight = 0.95ct, Total Metal Weight = 3.74 gram (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the diamonds cannot be ascertained. Therefore, weight of the diamonds are very much estimated. For accurate testing, weights, colour, and clarity gradings, the diamonds would require removal from the setting. The below replacement figure is based upon crafting a similar ring employing similar material and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
