Valuation for Traditional Retail Insurance Replacement

Item 1

One, lady's hand finished raised, 9ct yellow gold & diamond set, cluster ring. Plain, narrow, low half round, tapered band, measures 1.89mm width (at base) x 0.88mm depth, with curved underrail, open back settings underneath.

Feature, "entwined cluster design". Housing thirty seven round brilliant cut diamonds, claw, bead & rub-over set (mixed). The extended shoulders, of the band taper up, hollowed out underneath, both sides.

Polished finish, stamped "9K ESX" - acid tested as 9 carat gold. Finger size = M1/2.

The ring contains;

Seven claw set round brilliant cut diamonds, clarity is "P2 & P3"(mixed), colour is "G to H"(mixed), medium cut quality.
Dimensions = 2.39mm (average diameter) x 1.46mm (D-estimated)
Total Weight = 0.35ct (estimated - see NOTE below).

Thirty bead set round brilliant cut diamonds, clarity is "P2 & P3"(mixed), colour is "G to I"(mixed), medium cut quality.
Dimensions = 1.12mm (average diameter) x 0.68mm (D-estimated) (smallest)
Dimensions = 1.59mm (average diameter) x 0.97mm (D-estimated) (largest)
Total Weight = 0.30ct (estimated - see NOTE below).

Total Item Weight = 3.26 grams, Total Gemstone Weight = 0.65ct, Total Metal Weight = 3.13 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the diamonds cannot be ascertained. Therefore, weight of the diamonds are very much estimated. For accurate testing, weights, colour, and clarity gradings, the diamonds would require removal from the setting. The below replacement figure is based upon crafting a similar ring employing similar material and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
