Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct white gold, gem set, 'cluster' style ring, of hand-assembled construction.

Plain, narrow, low half round band of 3.13mm width (at base) x 0.98mm depth, with a hollow top and shoulders, open back settings, and a curved underrail.

Feature central symmetrical cluster fifteen round brilliant cut diamonds, varying in size, and claw set. The settings are secured between the extended and pointed shoulders in a 'wrap around' style of the plain and polished band.

Polished finish. Stamped '18CT' - acid tested as 18 carat gold. Ring size: O.

The ring contains:

Eleven claw set round brilliant cut diamonds, clarity is "Si & P1 & P2" (mixed), colour is "G to H" (mixed).

Dimensions = 1.95mm(Dia) x 1.19mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 2.10mm(Dia) x 1.28mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.36ct (estimated - see NOTE below)

Four claw set round brilliant cut diamonds, clarity is "Si & P1 & P2" (mixed), colour is "G to I" (mixed).

Dimensions = 3.27mm(Dia) x 1.99mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 4.57mm(Dia) x 2.79mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 1.00ct (estimated - see NOTE below)

Total Item Weight = 5.74 grams Total Gemstone Weight = 1.36ct Total Metal Weight = 5.47 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings.
