Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct white gold, gem set, multistone ring, of hand-assembled construction.

Plain, narrow, low half round band of 2.13mm width (at base) x 1.44mm depth, with a curved underrail.

Feature central four claw setting, housing one Princess cut diamond, claw set. The setting is secured to the underrail, and in between the extended and square shoulders, of the plain and polished band. Each of the shoulders houses one row of seven round brilliant cut diamonds, varying slightly in size, and claw set.

Polished finish.

Stamped '750' - acid tested as 18 carat gold.

Ring size: M.

The ring contains:

One claw set Princess cut diamond, clarity is "Si2", colour is "G".

Dimensions = 5.57mm(L) x 5.57mm(W) x 4.03mm(D-estimated) x 3.5%(Girdle Thickness)

Total Weight = 1.06ct (known weight - see NOTE below)

Fourteen claw set round brilliant cut diamonds, clarity is "Vs & Si" (mixed), colour is "G to I" (mixed).

Dimensions (average) = 1.70mm(Dia) x 1.04mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.28ct (estimated - see NOTE below)

Total Item Weight = 3.71 grams

Total Gemstone Weight = 1.34ct

Total Metal Weight = 3.44 grams (estimated)

NOTE: The diamond has been certified by Messrs. Gemological Institute of America (GIA) Certificate number: 246669995993 Dated: July 03, 2023. The diamond has also been laser inscribed upon the girdle with GIA (logo) and 2466995993. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
