## Valuation for Traditional Retail Insurance Replacement

### Item 1

One, 18ct white gold, gem set, pendant, of hand-assembled construction.

Feature central double three claw setting, housing one pear shaped natural amethyst, claw set. Surrounding is a series of decorative three dimensional wires, housing a total of one hundred and twenty-six round brilliant cut diamonds, claw set. The pendant is finished with a round articulated bail, also embellished with six round brilliant cut diamonds, claw set.

Pendant dimensions = 47.00mm (ave. length) x 25.26mm (ave. width) x 9.02mm (ave. depth).

Polished finish.

Stamped '750 \* 113 CT' - acid tested as 18 carat gold.

The pendant contains:

One claw set pear shaped natural amethyst, colour is "purple".

Dimensions = 23.25mm(L) x 14.47mm(W) x 8.21mm(D-estimated)

Total Weight = 13.18ct (estimated - see NOTE below)

One Hundred And Thirty Two claw set round brilliant cut diamonds, clarity is "Vs & Si" (mixed), colour is "G to J" (mixed).

Dimensions = 1.15mm - 1.10mm x 0.67mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.79ct (estimated - see NOTE below)

Total Item Weight = 10.00 grams Total Gemstone Weight = 13.97ct Total Metal Weight = 7.21 grams (estimated)
