## Valuation for Traditional Retail Insurance Replacement

### Item 1

One, lady's hand finished, raised 18ct white gold & diamond set, solitaire ring. Plain, narrow, low half round, tapered band, measures 1.69mm width (at base) x 1.28mm depth, with curved underrail.

Feature, "solitaire style" ring design. Comprising, a raised, six claw setting to top, houses one round brilliant cut diamond (laser inscribed), claw set. The extended shoulders, of the band, tapers up to the top, from both sides.

Polished finish, stamped "18K michael hill H52688" - acid tested as 18 carat gold.

Finger size = M.

The ring contains;

One claw set round brilliant cut diamond, clarity is "Si2", colour is "G", good cut quality.

Dimensions = 5.15mm (average diameter) x 3.14mm (D-estimated)

Total Weight = 0.50ct (estimated - see NOTE below).

Total Item Weight = 2.98 grams, Total Gemstone Weight = 0.50ct, Total Metal Weight = 2.88 grams (estimated)

NOTE: The diamond has been certified by, and is the opinion of, Messrs. Australian Diamond Grading Laboratory, Certificate no. H52688. Dated 01/09/2014. The diamond has also been laser inscribed upon the girdle with ADGL (logo) and H52688 michael hill.

NOTE: Due to setting constraints, the exact dimensions of the diamond cannot be ascertained. Therefore, weight of the diamond are very much estimated. For accurate testing, weights, colour, and clarity gradings, the diamond, would require removal from the setting. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
