Valuation for Traditional Retail Insurance Replacement

Item 1

One, lady's 2pce set, hand-assembled raised, 18ct yellow gold & diamond set, rings. Plain, narrow, low half round, tapered band, measure a combined width 3.58mm x 1.20mm depth, with curved underrail.

Feature, "2pce ring set". Comprising, asolitaire ring, houses one round brilliant cut diamond, rub-over set. The extended shoulders, of the band taper up and curl around the central setting, from both sides. The fitted contured side band, having a channel set row across the top, contains eight round brilliant cut diamonds, channel set.



Polished finish, stamped "750, 750". - acid tested both rings as 18 carat gold. Finger size = Q.

The ring set, contains;

One rub-over set round brilliant cut diamond, clarity is "Si", colour is "G", medium cut quality.

Dimensions = 3.90mm (average diameter) x 2.38mm (D-estimated)

Total Weight = 0.22ct (estimated - see NOTE below).

Eight channel set round brilliant cut diamonds, clarity is "Si & P1"(mixed), colour is "H to I"(mixed), medium cut quality.

Dimensions = 2.20mm (average diameter) x 1.34mm (D-estimated)

Total Weight = 0.32ct (estimated - see NOTE below).

Total Item Weight = 6.36 grams, Total Gemstone Weight = 0.54ct, Total Metal Weight = 6.25 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the diamond cannot be ascertained. Therefore, weight of the diamond are very much estimated. For accurate testing, weights, colour, and clarity gradings, the diamond, would require removal from the setting. The below replacement figure is based upon crafting a similar 2pce ring set, employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
