### Valuation for Traditional Retail Insurance Replacement

#### Item 1

One, 14ct white gold, gem set, 'solitaire' style ring, of cast construction.

Plain, narrow, high half round band of 1.57mm width (at base) x 1.51mm depth.

Feature central four claw setting, housing one oval shaped diamond, claw set. The setting is secured between the shoulders, of the plain and polished band.

Polished finish.

Stamped '14K michael hill 474139626' - acid tested as 14 carat gold.

Ring size: L.

The ring contains:

One claw set oval shaped diamond, clarity is "P1", colour is "G".

Dimensions = 7.50mm(L) x 5.50mm(W) x 3.64mm(D-estimated) x 5%(Girdle Thickness)

Total Weight = 1.01ct (known weight - see NOTE below)

Total Item Weight = 2.67 grams

Total Gemstone Weight = 1.01ct

Total Metal Weight = 2.47 grams (estimated)

NOTE: The diamond has been certified by and is the opinion of Messrs. International Gemological Institute, Certificate no. 474139626 Dated May 6, 2021. The diamond has also been laser inscribed upon the girdle with IGI (logo) and 474139626. No diamond certificate or paperwork was presented at the time of this valuation. Due to setting constraints, the exact dimensions of the gemstone cannot be ascertained. Therefore, weight of the gemstone is very much an estimation. For an accurate weight, colour, and clarity grading, the gemstone requires removal from the setting. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
