## Valuation for Traditional Retail Insurance Replacement

## Item 1

One, 10ct white gold, diamond set, multistone ring, of cast construction.

Plain, narrow, low half round, tapered band of 3.58mm width (at base) x 1.37mm depth, with a hollow top and shoulders, open back settings, and a cut out underrail.

Feature two diagonal rows of seven round brilliant cut diamonds, across the top of the band, channel set. There is one groove to the top and bottom framing the rows of diamonds, and down the shoulders. The settings are secured between the shoulders of the plain and polished band.



Polished finish.

Stamped '10K MHJ .20' - acid tested as 9 carat gold.

Ring size: U.

The ring contains:

Fourteen channel set round brilliant cut diamonds, clarity is "P2 & P3" (mixed), colour is "G to H" (mixed). Dimensions (average) = 1.60mm(Dia) x 0.98mm(D-estimated) x 2%(Girdle Thickness)
Total Weight = 0.24ct (estimated - see NOTE below)

Total Item Weight = 4.33 grams Total Gemstone Weight = 0.24ct Total Metal Weight = 4.28 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
