Valuation for Traditional Retail Insurance Replacement

Item 1

One lady's, hand finished, raised 9ct yellow gold & gemstone set, multistone ring. Plain, narrow, low half round, tapered band, measures 2.20mm width (at base) x 1.16mm depth, with curved underrail, open back settings, underneath.

Feature, "solitaire style" with shoulder stones. Comprising, a raised double four claw setting to centre, rhodium plated, houses one oval-shaped, faceted, natural sapphire, claw set. The extended shoulders, taper up to the top, each shoulder terminates with a vertical channel & channel setting, to both sides. Each shoulder contains four round brilliant cut diamonds, channel set.

Polished finish, stamped "375 [M]" - acid tested as 9 carat gold.

Finger size = M1/2.

The ring contains;

One claw set oval-shaped, faceted, natural sapphire, colour is "dark, blue/bluish green".
Dimensions = 6.90mm (L) x 5.20mm (W) x 3.38mm (D-estimated)
Total Weight = 0.99ct (estimated - see NOTE below).

Eight channel set round brilliant cut diamonds, clarity is "Si & P1"(mixed), colour is "H to I"(mixed), medium cut quality.
Dimensions = 1.60mm (average diameter) x 0.98mm (D-estimated) (smallest)
Dimensions = 1.70mm (average diameter) x 1.04mm (D-estimated) (largest)
Total Weight = 0.14ct (estimated - see NOTE below).

Total Item Weight = 3.15 grams, Total Gemstone Weight = 1.13ct, Total Metal Weight = 2.92 grams (estimated)

NOTE: limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
