Valuation for Traditional Retail Insurance Replacement

Item 1

One, 9ct yellow gold and rhodium plated, gem set, multistone, 'cluster' style ring, of cast construction.

Plain, narrow, low half round, tapered band of 1.40mm width (at base) x 0.92mm depth, with hollow top and shoulders, open back settings, and a curved underrail.

Feature central eight claw setting, housing one oval sapphire, claw set. Surrounding is one row of fourteen round brilliant cut diamonds, claw set. The top plate is supported with an open wire base, and is secured between the extended and pointed shoulders, of the plain and polished band. Rhodium plating to the setting areas.



Polished finish. Stamped 'AB 9CT' - acid tested as 9 carat gold. Ring size: L 1/2.

The ring contains:

One claw set oval shaped natural sapphire, colour is "black".

Dimensions = 9.05mm(L) x 7.05mm(W) x 4.41mm(D-estimated)

Total Weight = 2.36ct (estimated - see NOTE below)

Fourteen claw set round brilliant cut diamonds, clarity is "P1 & P2 & P3" (mixed), colour is "G to I" (mixed).

Dimensions (average) = 2.00mm(Dia) x 1.22mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.42ct (estimated - see NOTE below)

Total Item Weight = 2.01 grams Total Gemstone Weight = 2.78ct Total Metal Weight = 1.45 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
