Valuation for Traditional Retail Insurance Replacement

Item 1

One, lady's hand finished, raised 18ct white gold & diamond set, multistone ring. Plain, narrow, low half round, tapered band, measures 2.23mm width (at base) x 1.29mm depth, with open back, settings underneath.

Feature; "single row style" ring design. Comprising, a curved claw setting to top, runs across the band. The extended shoulders, of the band tapers up to the top, from both sides.

Polished finish, stamped "MHJ 750,.25" - acid tested as 18 carat gold.

Finger size = I.

the ring contains;

- Ten claw set round brilliant cut diamonds, clarity is "P1 & P2"(mixed), colour is "G to H"(mixed inset), medium cut quality.
- Dimensions = 1.80mm (average diameter) x 1.10mm (D-estimated) (smallest)
- Dimensions = 2.00mm (average diameter) x 1.22mm (D-estimated) (largest)
- Total Weight = 0.25ct (estimated - see NOTE below).

Total Item Weight = 2.70 grams, Total Gemstone Weight = 0.25ct, Total Metal Weight = 2.65 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the diamonds cannot be ascertained. Therefore, weight of the diamonds are very much estimated. For accurate testing, weights, colour, and clarity gradings, the diamonds, would require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
