Valuation for Traditional Retail Insurance Replacement

Item 1

One, lady's hand-assembled, 9ct yellow gold & diamond set, flexible link necklet/pendant.

Feature, "drop style" pendant to center, contains one round brilliant cut diamond, rub-over set. The pendant is suspended from a snake style chain, with a parrot clasp closure attached.

Polished finish, stamped "375" - acid tested as 9 carat gold.

Pendant/necklet dimensions = 48.50cm (total length) x 0.99mm (width) x 0.99mm (depth).

Pendant dimensions 10.91mm (length) x 5.63mm (width) x 3.16mm (depth).



The necklet/pendant contains:

One rub over set round brilliant cut diamond, clarity is "P2", colour is "I", medium cut quality.

Dimensions = 3.68mm (Diameter) x 2.24mm (D-estimated)

Total Weight = 0.19ct (estimated - see NOTE below)

Total Item Weight = 3.99 grams, Total Gemstone Weight = 0.19ct, Total Metal Weight = 3.95 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the diamond cannot be ascertained. Therefore, weight of the diamond are very much estimated. For accurate testing, weights, colour, and clarity gradings, the diamond would require removal from the setting. The below replacement figure is based upon crafting a similar necklet/pendant combination employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
