Valuation for Traditional Retail Insurance Replacement

Item 1

One, gents hand finished, raised 9ct yellow gold & diamond set, multistone ring. Plain, wide, low half round, tapered band, measures, 3.80mm width (at base) x 1.25mm depth, with cut-out underrail, open back settings, underneath.

Feature, "rectangular shaped" top, channel set rows to the angle, contains twenty three round brilliant cut diamonds, channel set. The extended shoulders, of the band, tapers up, to the top, each shoulder fluted with a rhodium plate, highlight to centre, both sides.

Polished finish, stamped "9K, 0.50ct" - acid tested as 9 carat gold.

the ring contains;

Twenty Three channel set round brilliant cut diamonds, clarity is "P2 & P3"(mixed), colour is "G to H"(mixed), medium cut quality.
Dimensions = 1.67mm (average diameter) x 1.02mm (D-estimated) (smallest)
Dimensions = 1.78mm (average diameter) x 1.09mm (D-estimated) (largest)
Total Weight = 0.50ct (estimated - see NOTE below).

Total Item Weight = 5.88 grams, Total Gemstone Weight = 0.50ct, Total Metal Weight = 5.78 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the diamonds cannot be ascertained. Therefore, weight of the diamonds are very much estimated. For accurate testing, weights, colour, and clarity gradings, the diamonds would require removal from the setting. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
