Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct white gold, 'solitaire' design, diamond set ring, of cast construction.

Plain, narrow, tapered band of 2.46mm in width (at base) x 0.91mm depth, with open back setting.

Feature 'solitaire' style ring design, consisting of a four claw 'cross-over' style ring design, housing one round brilliant cut diamond, claw set. The claws are formed by the shoulder terminations of the plain and polished band.

Polished finish.

Stamped '750 SBB' - acid tested as 18 carat gold.

Finger size is N.

The ring contains:

One claw set round brilliant cut diamond, clarity 'Vs2', colour 'G'.

Dimensions = 5.30mm(L) x 5.27mm(W) x 3.20mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.58ct (estimated - see NOTE below)

Total Item Weight = 3.58 grams

Total Gemstone Weight = 0.58ct

Total Metal Weight = 3.46 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstone cannot be ascertained. Therefore, weight of the gemstone is very much an estimation. For an accurate weight, colour, and clarity grading, the gemstone requires removal from the setting. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only.
