Valuation for Traditional Retail Insurance Replacement

Item 1

One, 9ct white gold, multistone, gem set ring, of cast construction.

Plain, narrow, tapered band of 1.87mm in width (at base) x 1.28mm depth, with a curved and cut-out underrail, open to the centre.

Feature 'cluster' style ring design, consisting of a central 'cluster', housing twenty-one round brilliant cut diamonds, tapering in size largest to the smallest. Surrounded by twenty-four round brilliant cut diamonds, claw set. Secured between the extended shoulders of the plain and polished band. Each shoulder having five round brilliant cut diamonds, tapering in size, claw set.

Polished finish.

Stamped '375 JP02' - acid tested as 9 carat gold.

Finger size is O.

The ring contains:

Fifty Five claw set round brilliant cut diamonds, clarity 'P1 to P3' (mixed), colour 'H to J' (mixed).

Dimensions = 0.80mm(Dia) x 0.49mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 2.50mm(Dia) x 1.53mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 1.00ct (estimated - see NOTE below)

Total Item Weight = 4.10 grams

Total Gemstone Weight = 1.00ct

Total Metal Weight = 3.90 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
