Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct white gold, three diamond set ring, of cast construction.

Plain, narrow, tapered band of 1.78mm in width (at base) x 1.17mm depth, with open back settings.

Feature three setting ring design, housing three round brilliant cut diamonds, largest to the centre, shared claw set. Secured between the shoulders of the plain and polished band.

Polished finish.

Stamped '750 * 2020 VI' - acid tested as 18 carat gold.

Finger size is M 1/2.

The ring contains:

Three claw set round brilliant cut diamonds, clarity 'Si & P1' (mixed), colour 'G to H' (mixed).

Dimensions = 4.32mm(Dia) x 2.72mm(D-estimated) x 4%(Girdle Thickness) (smallest)

Dimensions = 4.45mm(Dia) x 2.85mm(D-estimated) x 4%(Girdle Thickness) (largest)

Total Weight = 1.00ct (estimated - see NOTE below)

Total Item Weight = 3.00 grams Total Gemstone Weight = 1.00ct

Total Metal Weight = 2.80 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only.
