Valuation for Traditional Retail Insurance Replacement

Item 1

One, hand-assembled, 18ct yellow gold, multistone, gem set ring.

Plain, wide, tapered band of 3.93mm in width (at base) x 0.96mm depth, with hollow top and shoulders, and open back settings.

Feature central four 'corner' claw setting, housing four Princess cut diamonds, invisible set. A three row design, spanning across the top of the plain and polished band, houses a total of seventy-two round cut diamonds, tapering in size, claw set.

Polished finish - stamped '750 0.35ct 0.45ct' - acid tested as 18 carat gold. Finger size is P.

The ring contains:

Four corner set Princess cut diamonds, clarity 'Vs', colour 'G to H' (mixed).
Dimensions = 2.61mm(L) x 2.60mm(W) x 1.60mm(D-estimated) x 2%(Girdle Thickness)
Total Weight = 0.35ct (estimated - see NOTE below)

Seventy Two claw set round brilliant cut diamonds, clarity 'Vs, Si & P1' (mixed), colour 'G to H' (mixed).
Dimensions = 1.00mm(Dia) x 0.61mm(D-estimated) x 2%(Girdle Thickness) (smallest)
Dimensions = 1.25mm(Dia) x 0.76mm(D-estimated) x 2%(Girdle Thickness) (largest)
Total Weight = 0.45ct (estimated - see NOTE below)

Total Item Weight = 4.32 grams - Total Gemstone Weight = 0.80ct - Total Metal Weight = 4.16 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
