Valuation for Traditional Retail Insurance Replacement

Item 1

One, 9ct white gold, gem set, 'solitaire' style ring, of cast construction.

Plain, narrow, low half round, tapered band of 1.94mm width (at base) x 1.26mm depth.

Feature central decorative six claw setting, housing one round brilliant cut diamond, claw set. The setting is secured between the extended and pointed shoulders, of the plain and polished band.

Polished finish.

Stamped '375 Hardy Brothers makers mark' - acid tested as 9 carat gold.

Ring size: P.

The ring contains:

One claw set round brilliant cut diamond, clarity is "P2", colour is "G".

Dimensions = 5.07mm(L) x 5.06mm(W) x 3.09mm(D-estimated) x 3%(Girdle Thickness)

Total Weight = 0.50ct (estimated - see NOTE below)

Total Item Weight = 2.10 grams

Total Gemstone Weight = 0.50ct

Total Metal Weight = 2.00 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstone cannot be ascertained. Therefore, weight of the gemstone is very much an estimation. For an accurate weight, colour, and clarity grading, the gemstone requires removal from the setting.
