Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct yellow gold and 18ct white gold, gem set, multistone style ring, of hand-assembled construction.

Plain, narrow, low half round, tapered band of 1.96mm width (at base) x 1.36mm depth, with open back settings, and a curved underrail.

Feature central white gold channel setting, housing one Princess cut diamond, end set. The setting is secured between the extended and square 'ramp' style shoulders, of the plain and polished yellow gold band.

Polished finish.

Stamped 'MHJ 18ct' - acid tested as 18 carat gold.

Ring size: L.

The ring contains:

One end set Princess cut diamond, clarity is "Si2", colour is "G".

- Dimensions = 3.37mm(L) x 3.37mm(W) x 2.39mm(D-estimated) x 6%(Girdle Thickness)
- Total Weight = 0.24ct (estimated - see NOTE below)

Eight channel set Princess cut diamonds, clarity is "Vs & Si" (mixed), colour is "J".

- Dimensions = 1.70mm(L) x 1.70mm(W) x 1.21mm(D-estimated) x 2%(Girdle Thickness) (smallest)
- Dimensions = 1.80mm(L) x 1.80mm(W) x 1.28mm(D-estimated) x 2%(Girdle Thickness) (largest)
- Total Weight = 0.26ct (estimated - see NOTE below)

Total Item Weight = 3.94 grams Total Gemstone Weight = 0.50ct Total Metal Weight = 3.84 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only.
