Valuation for Traditional Retail Insurance Replacement

Item 1

One, 14ct white gold, gem set, 'cluster' style ring, of hand-assembled construction.

Plain, narrow, low half round band of 1.79mm width (at base) x 1.50mm depth, with a 'cross over' style underrail.

Feature cushion shaped top plate, with a central four claw setting, housing one round brilliant cut diamond, claw set. Surrounding is one row of sixteen round brilliant cut diamonds, claw set. The top plate is secured to the underrail, and in between the extended and square shoulders, of the plain and polished band. Each of the shoulders houses one row of nine round brilliant cut diamonds, claw set.

Polished finish.

Stamped '14K 0.95 michael hill' - acid tested as 18 carat gold.

Ring size: H 1/2.

The ring contains:

One claw set round brilliant cut diamond, clarity is "Si2", colour is "J".

Dimensions = 5.37mm(L) x 5.35mm(W) x 3.40mm(D-estimated) x 3%(Girdle Thickness)

Total Weight = 0.61ct (estimated - see NOTE below)

Thirty Four claw set round brilliant cut diamonds, clarity is "Si & P1 & P2" (mixed), colour is "H to J" (mixed).

Dimensions = 1.25mm(Dia) x 0.76mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.34ct (estimated - see NOTE below)

Total Item Weight = 2.82 grams Total Gemstone Weight = 0.95ct Total Metal Weight = 2.64 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings.
