The large diamonds are platinum illusion set in a six claw collet, platinum six claw collet and platinum four claw collet set. The sapphires are platinum rub over set and the diamonds are platinum bead set in the surrounding flared shoulder.

The band is hand made. Ring Size: M.

1 x Diamond – round brilliant cut, 3.4mm, estimated weight 0.15ct, Clarity SI, Colour F-G, chipped.

2 x Diamonds – single cut, 1.8mm to 1.9mm, estimated weight 0.025ct each, Clarity VS-SI, Colour F-H.

2 x Diamonds – single cut, 1.5mm, estimated weight

0.015ct each, Clarity VS-SI, Colour F-H.

10 x Diamonds – single cut, 1.1mm to 1.2mm, estimated weight 0.005ct each, Clarity VS-SI, Colour F-H.

3 x Natural Sapphire – square faceted, 2.4mm x 2.4mm, estimated weight 0.10ct each, moderate blue colour.

Due to the stones being set the weight, clarity and colour are estimated. Total Diamond Weight: 0.88ct.
