Description DIAMOND RING

Stamped 18KT LOVE VW VERA WANG. 18ct White gold.
One larger diamond is four claw set centred. Smaller diamonds are claw chener set surrounding with mill grain detailing and having sapphires two claw set upon each under-rail and angled four claw set upon each shoulder. Diamonds are bead set upon and along the edges of each open and flared shoulder with mill grain detailing. Exact replacement may be difficult.
