The slightly rounded, open band contains raised edges and measures 7.7mm to 9.1mm in width. Cast – hand assembled manufacture. Ring Size: S.

- 1 x Diamond – round brilliant cut, 3.5mm x 3.5mm x 2.3mm, estimated weight 0.17ct, Clarity VS, Colour C5 Dark Champagne.
- 2 x Diamonds – round brilliant cut, 2.5mm, estimated weight 0.06ct each, Clarity VS-SI, Colour C6 Dark Champagne.
- 2 x Diamonds – round brilliant cut, 2.0mm, estimated weight 0.03ct each, Clarity SI, Colour C5-C6 Dark Champagne.
- 29 x Diamonds – round brilliant cut, 1.8mm to 1.9mm, estimated weight 0.025ct each, Clarity SI, Colour G-H, seven are chipped.

Due to the stones being set the weight, clarity and colour are estimated.
