Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct white gold, gem set, 'solitaire' style dress ring, of cast construction.

Plain, narrow, low half round, tapered band of 3.55mm width (at base) x 1.12mm depth, with a hollow top and shoulders.

Feature 'vintage' style ring, with a raised decorative four claw setting, housing one round brilliant cut diamond, claw set. The extended and pointed shoulders, create two of the claws of the central setting, and lengthen out from the plain and polished band.

Polished finish.

Stamped '750 628AL' - acid tested as 18 carat gold.

Ring size: N 1/2.

The ring contains:

One claw set round brilliant cut diamond, clarity is "Vs", colour is "G".

Dimensions = 3.93mm(L) x 3.91mm(W) x 2.39mm(D-estimated) x 3%(Girdle Thickness)

Total Weight = 0.23ct (estimated - see NOTE below)

Total Item Weight = 5.86 grams

Total Gemstone Weight = 0.23ct

Total Metal Weight = 5.81 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
