Valuation for Traditional Retail Insurance Replacement

One, 14ct white gold, gem set, 'solitaire' style ring, of hand-assembled construction.

Plain, narrow, low half round, tapered band of 1.94mm width (at base) x 1.05mm depth, with a curved underrail.

Feature extended and pointed shoulders,

Polished finish.

Stamped '14K michael hill 47650100516' - acid tested as 14 carat gold.

Ring size: I.

The ring contains:

One claw set round brilliant cut diamond, clarity is "P2", colour is "G".

Dimensions = 5.00mm(L) x 4.92mm(W) x 3.19mm(D-estimated) x 3%(Girdle Thickness)

Total Weight = 0.50ct (estimated - see NOTE below)

Total Item Weight = 2.20 grams

Total Gemstone Weight = 0.50ct

Total Metal Weight = 2.10 grams (estimated)



NOTE: The diamond has been laser inscribed upon the girdle with michael hill and 47650100516. The number refers to a Gemological Science International (GSI) Report of Authenticity: 47650100516. No diamond certificate or paperwork was presented at the time of this valuation. Due to setting constraints, the exact dimensions of the gemstone cannot be ascertained. Therefore, weight of the gemstone is very much an estimation. For an accurate weight, colour, and clarity grading, the gemstone requires removal from the setting. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
