Valuation for Traditional Retail Insurance Replacement

Item 1

One, platinum, gem set, 'three stone' style ring, of handmade construction.

Plain, narrow, low half round, tapered band of 1.09mm width (at base) x 0.74mm depth, with open back settings, and a curved underrail.

Feature 'vintage' style ring with three illusion plates, within six claw settings, spanning across the top of the band, graduating in size, largest to the centre. Each setting houses one old cut diamond, claw set. The settings are secured to the underrail, and in between the extended and pointed shoulders, of the plain and polished band.

Polished finish.

Unstamped - acid tested as platinum.

Ring size: K 1/2.

The ring contains:

One claw set old cut diamond, clarity is "P1", colour is "G".

Dimensions = 4.15mm(L) x 4.05mm(W) x 2.68mm(D-estimated)

Total Weight = 0.28ct (estimated - see NOTE below)

Two claw set old cut diamonds, clarity is "Si & P1 & P2" (mixed), colour is "G to H" (mixed).

Dimensions (average) = 3.73mm(Dia) x 2.40mm(D-estimated)

Total Weight = 0.42ct (estimated - see NOTE below)

Total Item Weight = 2.68 grams Total Gemstone Weight = 0.70ct Total Metal Weight = 2.54 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
