Valuation for Traditional Retail Insurance Replacement

Item 1

One, 9ct yellow gold, gem set, multistone ring, of cast construction.

Plain, narrow, low half round, tapered band of 2.64mm width (at base) x 0.99mm depth, with open back settings.

Feature one row of twelve round brilliant cut diamonds, spanning across the top of the band, graduating in size, largest to the centre, and channel set. The settings are secured between the tapering shoulders, of the plain and polished band.



Polished finish.

Stamped '375' - acid tested as 9 carat gold.

Ring size: J.

The ring contains:

Twelve channel set round brilliant cut diamonds, clarity is "Si & P1 & P2" (mixed), colour is "light tinted brown".

Dimensions = 2.72mm(Dia) x 1.66mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 3.33mm(Dia) x 2.03mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 1.00ct (estimated - see NOTE below)

Total Item Weight = 2.53 grams

Total Gemstone Weight = 1.00ct

Total Metal Weight = 2.33 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings.
