### Valuation for Traditional Retail Insurance Replacement

#### Item 1

One, lady's hand-assembled raised, 18ct yellow gold & diamond set, flexible link pendant/necklet.

Feature; "drop style Pendant/necklet. Comprising a raised rub-over setting, houses one round brilliant cut diamond, rub-over set, with a fixed v-shaped bail attached to top. Suspended from a fine figaro linked 3 in 1 style chain, with a bolt ring clasp closure attached.

Polished finish, stamped "18ct, 750, 1236VI" - acid tested as 18 carat gold.

Necklet dimensions = 50.00cm (total length) x 1.43mm (width) x 0.65mm (depth).

The necklet/pendant contains:

One rub-over set round brilliant cut diamond, clarity is "P1", colour is "H", medium cut quality.

Dimensions = 4.00mm (average diameter) x 2.66mm (D-estimated)

Total Weight = 0.25ct (estimated - see NOTE below).

Total Item Weight = 3.76 grams, Total Gemstone Weight = 0.25ct, Total Metal Weight = 3.71 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the diamond cannot be ascertained. Therefore, weight of the diamond are very much estimated. For accurate testing, weights, colour, and clarity gradings, the diamond, would require removal from the setting. The below replacement figure is based upon crafting a similar pendant/necklet combo, employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
