Valuation for Traditional Retail Insurance Replacement

Item 1

One, 10ct white gold, gem set, 'cluster' style ring, of cast construction.

Plain, narrow, low half round, tapered band of 2.03mm width (at base) x 1.29mm depth, with a hollow top and shoulders, open back settings, and a decorative underrail.

Feature square top plate, housing nine round brilliant cut diamonds, largest to the centre, invisibly and claw set. The top plate is secured between the 'split' style shoulders, of the plain and polished band. Each of the shoulders houses fourteen single cut diamonds, claw set. Millegrain detail to the edges.



Polished finish. Stamped '10CT MHJ 0.41' - acid tested as approximately 10 carat gold. Ring size: O.

The ring contains:

One claw set round brilliant cut diamond, clarity is "P2", colour is "I".

Dimensions = 3.00mm(Dia) x 1.83mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.11ct (estimated - see NOTE below)

Thirty Six claw set round brilliant cut and single cut diamonds, clarity is "Si & P1 & P2 & P3" (mixed), colour is "H to I" (mixed).

Dimensions = 0.90mm(Dia) x 0.55mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 2.10mm(Dia) x 1.28mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.30ct (estimated - see NOTE below)

Total Item Weight = 3.46 grams Total Gemstone Weight = 0.41ct Total Metal Weight = 3.38 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
