Valuation for Traditional Retail Insurance Replacement

Item 1

One, lady's hand-assembled raised, 18ct yellow gold & diamond set, pendant.

Feature; "drop style floral design" pendant. Housing, five round brilliant cut diamonds, claw set. Contains thirteen round brilliant cut diamonds, claw & channel set (mixed). The pendant having a wire construction, open back settings, underneath. Suspended from a v-shaped, articulated bail to top.

Polished finish, stamped "850, UTM" - acid tested & x-rayed as 18 carat gold.

Pendant dimensions = 30.00mm (total length) x 15.00mm (width) x 7.24mm (depth).

The pendant contains:

Five claw set round brilliant cut diamonds, clarity is "Vs & Si"(mixed), colour is "G to H"(mixed), medium cut quality.

Dimensions = 3.40mm (average diameter) x 2.07mm (D-estimated) (smallest)

Dimensions = 3.60mm (average diameter) x 2.20mm (D-estimated) (largest)

Total Weight = 0.75ct (estimated - see NOTE below).

Thirteen channel set round brilliant cut diamonds, clarity is "Vs & Si"(mixed), colour is "G to H"(mixed), medium cut quality.

Dimensions = 1.10mm (average diameter) x 0.67mm (D-estimated) (smallest)

Dimensions = 1.50mm (average diameter) x 0.92mm (D-estimated) (largest)

Total Weight = 0.17ct (estimated - see NOTE below).

Total Item Weight = 3.50 grams, Total Gemstone Weight = 0.92ct, Total Metal Weight = 3.32 grams (estimated).

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the diamond cannot be ascertained. Therefore, weight of the diamond are very much estimated. For accurate testing, weights, colour, and clarity gradings, the diamond, would require removal from the setting. The below replacement figure is based upon crafting a similar pendant employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
