One hand assembled 18k white gold multi-stone diamond ring, plain flat profile tapered shank of width 3.14mm – 2.65mm x 1.28mm. Centre set with 3 x princess cut diamonds – each in a “4” claw coronet open back setting, total of 6 x channel set princess cut diamonds on either side of the up-swept shoulders, polished finish and stamped MHJ 750 – 1.50.

02 x princess cut diamonds, colour = I – J, clarity = SI2, estimated.

Weight = 0.66ct estimated.

06 x princess cut diamonds, colour = H – I, clarity = VS – SI, estimated.
Dimensions = 1.80 x 1.75 x 1.37mm, average.
Weight = 0.18ct estimated.

Total Item Weight = 5.70gm estimated.
Total Gem Weight = 1.50ct estimated.
