## Valuation for Traditional Retail Replacement

## Item 1

One, pair of lady's, hand-assembled raised, 9ct yellow gold and gemstone set, screw-back stud earrings.

Feature "screw-back, cameo" earrings, comprising a left face & right face, cameo, claw set. Drops to a twisted rope style frame. Both earrings come with a threaded post and hook fitting attached.

Polished finish, stamped "H & P 9CT" - acid tested as 9 carat gold.

Earring dimensions = 16.33mm (total length) x 9.48mm (width) x 7.04mm depth.

The earrings contain

Two claw set oval- shaped cameos depicting a left side & right side, head of a lady figure, colour is "cream on tan". Dimensions = 10.28mm (length) x 8.27mm (width) x 2.32mm (D-estimated)

Total Item Weight = 2.70 grams.

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar screw-back earrings employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
