## Valuation for Traditional Retail Insurance Replacement

### Item 1

One, hand-assembled, 18ct white gold, cluster style, gem set, dress ring.

Plain, narrow, tapered band of 1.89mm in width (at base) x 0.90mm depth, with a curved underrail.

Feature central bezel setting, housing one round brilliant cut diamond, rub-over set. Mounted atop the pierced support base, all secured between the extended shoulders of the plain and polished band.

Polished finish - stamped '750 CG' - acid tested as 18 carat gold. Finger size is O.

The ring contains:

One rub over set round brilliant cut diamond, clarity 'P1', colour 'I'.  
Dimensions = 3.51mm(Dia) x 2.14mm(D-estimated) x 2%(Girdle Thickness)  
Total Weight = 0.16ct (estimated - see NOTE below)

Nine claw set single cut diamonds, clarity 'Si & P1' (mixed), colour 'I to J' (mixed).  
Dimensions = 1.85mm (average diameter)  
Total Weight = 0.24ct (estimated - see NOTE below)

Total Item Weight = 3.90 grams - Total Gemstone Weight = 0.40ct - Total Metal Weight = 3.82 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
