## Valuation for Traditional Retail Insurance Replacement

### Item 1

One, 9ct white gold, multistone, gem set ring, of cast construction.

Plain, narrow band of 1.32mm in width (at base) x 1.05mm depth, with hollow shoulders, and open back centre setting.

Feature central raised, 'cluster' style, housing nine round brilliant cut diamonds, tapering in size, claw set. Surrounded by twenty single cut diamonds, claw set. Pierced 'V' style sides of the settings. Secured between the extended shoulders of the plain and polished band. Each shoulder having six round brilliant cut diamonds, claw set.

Polished finish - stamped '9K' - acid tested as 9 carat gold. Finger size is N 1/2.

The ring contains:

Twenty One claw set round brilliant cut diamonds, clarity 'P1, P2 & P3' (mixed), colour 'H to J' (mixed).

Dimensions = 1.10mm(Dia) x 0.67mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 2.00mm(Dia) x 1.22mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.27ct (estimated - see NOTE below)

Twenty claw set single cut diamonds, clarity 'P2 & P3' (mixed), colour 'H to J'" (mixed).

Dimensions = 0.70mm (ave. diameter)

Total Weight = 0.06ct (estimated - see NOTE below)

Total Item Weight = 2.01 grams - Total Gemstone Weight = 0.33ct - Total Metal Weight = 1.94 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
