## Valuation for Traditional Retail Insurance Replacement

### Item 1

One, lady's, hand finished, raised 9ct yellow gold, diamond set, cluster style dress ring. Plain, narrow, low half round, tapered band, measures, 1.60mm width (at base) x 1.39mm depth, with curved underrail.

Feature, "cluster style" ring design, with shoulder stones. Comprising, square-shaped, step down, cluster setting, to top. The extended shoulders, taper up to the top, from both sides.

Polished finish, stamped "9k, 0.42ct" - acid tested as 9 carat gold. Finger size = O1/2.

The ring contains:

Nine illusion claw set Princess cut diamonds, clarity is "Si", colour is "H to I"(mixed), medium cut quality.  
Dimensions = 1.60mm (L) x 1.60mm (W) x 1.14mm (D-estimated)  
Total Weight = 0.21ct (estimated - see NOTE below).

Thirty Six bead set single cut diamonds, clarity is "Si & P1"(mixed), colour is "H to K"(mixed), medium cut quality.  
Dimensions = 1.00mm (average diameter)  
Total Weight = 0.19ct (estimated - see NOTE below).

Total Item Weight = 2.44 grams, Total Gemstone Weight = 0.40ct, Total Metal Weight = 2.36 grams (estimated)

NOTE: Limited gemmological testing, inset, Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
