Valuation for Traditional Retail Insurance Replacement

Item 1

One, lady's hand-assembled raised, 10ct white gold & 9ct white gold, diamond set, flexible link necklet/pendant.

Feature; "cluster style" drop pendant. Comprising, a flower cluster, in 9ct gold, housing nine round brilliant cut & single cut diamonds (mixed), illusion claw set. Attached to top an articulated v-shaped bail. Suspended from an ultra fine twisted curb link chain, with a bolt ring clasp closure fitted.

Polished finish, stamped "10kt XL (chain)" & 9k (faded) on bail. - acid tested.

Chain dimensions = 46.00cm (total length inclusive) x 0.54mm (width) x 0.54mm (depth).

Pendant dimensions 15.00mm (length) x 10.00mm (width) x 4.26mm (depth).

The necklet/pendant contains:

Nine illusion claw set round brilliant cut & single cut diamonds (mixed), clarity is "P2 & P3"(mixed), colour is "H to I"(mixed), medium cut quality.

Dimensions = 1.00mm (average diameter) x 0.61mm (D-estimated) (smallest)

Dimensions = 2.10mm (average diameter) x 1.28mm (D-estimated) (largest)

Total Weight = 0.14ct (estimated - see NOTE below).

Total Item Weight = 1.59 grams, Total Gemstone Weight = 0.14ct, Total Metal Weight = 1.56 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar necklet/pendant/combo, employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
