## Valuation for Traditional Retail Insurance Replacement

### Item 1

One lady's, hand-assembled raised, 18ct white gold & diamond set, 9ct white gold flexible link pendant/necklet.

Feature; "drop style" pendant/necklet design. Comprising, a four claw setting, solid to back, houses one round brilliant cut diamond, claw set. Attached to top, a plain v-shaped bail. Suspended from a flat curb linked, 9 carat gold chain, with a bolt ring clasp closure, fitted & attached.

Polished finish, stamped "18ct, 375 (Italy - chain)" - acid tested both.

Chain dimensions = 50.50cm (total length) x 1.43mm (width) x 0.73mm (depth).

Pendant dimensions = 13.65mm (length) x 6.83mm (width) x 3.81mm (depth).

The necklet/pendant contains:

One claw set round brilliant cut diamond, clarity is "Si", colour is "H", medium cut quality.  
Dimensions = 4.53mm (average diameter) x 2.76mm (D-estimated)  
Total Weight = 0.35ct (estimated - see NOTE below).

Total Item Weight = 1.07 grams, Total Gemstone Weight = 0.35ct, Total Metal Weight = 1.00 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the diamond cannot be ascertained. Therefore, weight of the diamond are very much estimated. For accurate testing, weights, colour, and clarity gradings, the diamond, would require removal from the setting. The below replacement figure is based upon crafting a similar necklet/pendant/chain combo employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
