Valuation for Traditional Retail Insurance Replacement

Item 1

One lady's, hand finished, raised 10ct yellow gold, rhodium plated, diamond set, multistone ring.

Plain, narrow, low half round, tapered band, measures, 1.73mm width (at base) x 0.97mm depth, with open back, underneath.

Feature, "trilogy style" ring design, Comprising, a raised trilogy setting, rhodium plated to highlight, contains twelve Princess cut diamonds tapering sizes, all Illusion claw set. The extended shoulders, of the band tapers up to the top, from both sides.



Polished finish, stamped "10K, U, N" - acid tested as approximately 10 carat gold. Finger size = T.

The ring contains;

Four illusion claw set Princess cut diamonds, clarity is "Si & P1"(mixed), colour is "H to J"(mixed), medium cut quality. Average dimensions = 2.49mm (L) x 2.49mm (W) x 1.77mm (D-estimated) Total Weight = 0.35ct (estimated - see NOTE below).

Eight illusion claw set Princess cut diamonds, clarity is "Si & P1"(mixed), colour is "H to I"(mixed), medium cut quality.

Average dimensions = 1.90mm (L) x 1.90mm (W) x 1.35mm (D-estimated)

Total Weight = 0.31ct (estimated - see NOTE below).

Total Item Weight = 3.66 grams, Total Gemstone Weight = 0.66ct, Total Metal Weight = 3.53 grams, (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
