## Valuation for Traditional Retail Insurance Replacement

## Item 1

One lady's, hand finished, raised, 18ct white gold & gemstone set (mixed), cluster dress ring. Plain, narrow, low half round, tapered band, measures 1.86mm width (at base) x 1.10mm depth, with open back, settings underneath.

Feature; "cluster style" ring design. Comprising, a raised four claw setting to centre. Drops to an oval surround, claw set. The extended shoulders, of the band, tapers slightly, to the top, both shoulders claw set.

Polished finish, stamped "750 CG" - acid tested as 18 carat gold, Finger size = L3/4.

The ring contains;



One claw set oval-shaped, faceted, natural aquamarine, colour is "extremely light, bluish green". Dimensions = 7.16mm (L) x 5.06mm (W) x 3.39mm (D-estimated) Total Weight = 0.69ct (estimated - see NOTE below).

Forty claw set round brilliant cut diamonds, clarity is "Si & P1"(mixed), colour is "G to H"(mixed), medium cut quality. Dimensions = 1.00mm (average diameter) x 0.61mm (D-estimated) (smallest) Dimensions = 1.30mm (average diameter) x 0.79mm (D-estimated) (largest) Total Weight = 0.32ct (estimated - see NOTE below).

Total Item Weight = 2.87 grams, Total Gemstone Weight = 1.01ct, Total Metal Weight = 2.67 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
