Valuation for Traditional Retail Insurance Replacement

Item 1

One lady's, hand-assembled raised, 18ct yellow gold, platinum & diamond set, multistone ring. Plain, narrow, low half round, tapered band, measures 2.13mm width (at base) x 1.40mm depth, with curved underrail, open back settings, underneath.



Feature; "bridge style" ring design. Comprising, a raised multi claw platinum setting to top, houses five early brilliant cut diamonds, tapering sizes, illusion claw set. The extended shoulders, of the yellow gold band tapers up to the platinum, pointed end terminations to both sides.

Polished finish, stamped "BKT, 18ct/Plat, J880" - acid tested & x-rayed.

Finger size = N.

The ring contains;

- Five illusion claw set early brilliant cut diamonds, clarity is "P1 & P2"(mixed), colour is "H to I"(mixed), medium cut quality.
- Dimensions = 1.70mm (average diameter) x 1.07mm (D-estimated) (smallest)
- Dimensions = 3.00mm (average diameter) x 1.89mm (D-estimated) (largest)
- Total Weight = 0.25ct (estimated - see NOTE below).

Total Item Weight = 2.84 grams, Total Gemstone Weight = 0.25ct, Total Metal Weight = 2.79 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring using all modern round brilliant cut diamonds of the same estimated weight, colour and clarity employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
