## Valuation for Traditional Retail Insurance Replacement

### Item 1

One, lady's hand finished, raised 18ct white gold & diamond set, multistone ring. Plain, wide, low half round, tapered band, measures 3.01mm width (at base) x 1.17mm depth, with curved underrail.

Feature; "solitaire style" ring design, with shoulder stones. Comprising, a raised four claw setting to top. Houses one Princess cut diamond, claw set. The extended shoulders, of the band, tapers up to the top. Each shoulder contains eight round brilliant cut diamond, bead set, to both sides.

Polished finish, stamped "750" - acid tested as 18 carat gold. Finger size = L.

the ring contains;

One claw set Princess cut diamond, clarity is "P1", colour is "H", medium cut quality.  
Dimensions = 5.60mm (L) x 5.53mm (W) x 4.00mm (D-estimated)  
Total Weight = 1.00ct (estimated - see NOTE below).

Sixteen bead set round brilliant cut diamonds, clarity is "Si", colour is "H", medium cut quality.  
Dimensions = 1.80mm (average diameter) x 1.10mm (D-estimated) (smallest)  
Dimensions = 1.90mm (average diameter) x 1.16mm (D-estimated) (largest)  
Total Weight = 0.40ct (estimated - see NOTE below).

Total Item Weight = 4.54 grams, Total Gemstone Weight = 1.40ct, Total Metal Weight = 4.26 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
